

CVHA Street Parking Notice



To ensure your vehicle is protected and all visitors and vehicles passing through have space in our neighborhood, please keep your vehicles parked within your garage or in your driveway when not in use. Large vehicles (delivery trucks, garbage trucks, fire trucks, ambulances, etc.) can have difficulty entering and navigating our neighborhoods when there are many cars parked on the streets. Leaving cars parked on the street could potentially result in damage to your vehicle that we all wish to avoid. Please note it is in violation of City of Carrollton to leave any vehicle parked longer than 48 hours on the street. At all times, it is unlawful in the City of Carrollton to park trailers or other dependent vehicles longer than 2 hours. It is also unlawful to park any bobtail, truck-tractor, road-trailer, trailer, semi-trailer, bus, and any other commercial motor vehicle over one-ton capacity on the street except when in use by city or commercial workers.

City of Carrollton Ordinance:

- **Sec. 72.08. - Parking for more than 48 hours prohibited.**

A person commits an offense by leaving an unattended vehicle or other private property standing or parked in a public street, alley or other public place for a continuous period of time longer than 48 hours.

- **Sec. 72.09. - Time limit for parking boat trailers, stock trailers and other dependent vehicles.**

It shall be unlawful for any person to park any boat trailers, stock trailers, recreational vehicles (RV's) or any other vehicle unable to operate under its own power on any public street, roadway, or avenue within the city for a period longer than a two-hour duration.

- **Sec. 72.60. - Responsibility of vehicle owner for violations of provisions.**

(A)

No person shall allow, permit or suffer any vehicle registered in his name to stand or park in any street in the city in violation of any provision of this chapter regulating the standing or parking of vehicles.

(B)

If a vehicle is found unattended or unoccupied upon a street, highway, alley or other public place in violation of any provision of this chapter regulating the stopping, standing or parking of vehicles, the same is hereby declared a nuisance per se, and the fact that the vehicle is unattended or unoccupied by any person shall be prima facie evidence that the owner unlawfully stopped, placed or parked that vehicle. Proof of the ownership may be made by a copy of the registration of the vehicle with the Texas Department of Transportation or County Motor Vehicle License Department showing the name of the person to whom the state highway license plates were issued. This proof shall constitute prima facie evidence of the ownership of the motor vehicle by the person to whom the certificate of registration was issued.

Sec. 72.11. - Parking of trucks and other commercial vehicles.

It shall be unlawful for any person to park any bobtail, truck-tractor, road-trailer, trailer, semi-trailer, bus, and any other commercial motor vehicle over one-ton capacity upon any public street, alley, parkway, boulevard, public place or railroad right-of-way in the city. This provision shall not apply to street construction equipment, maintenance and repair equipment or trucks, rollers and implements, equipment trailers, vehicles used by public service utility companies engaged in repairing or extending public service utilities, motor buses when taking on or discharging passengers at the customary bus stops, vehicles parked in designated loading zones while they are in the act of accepting from the immediate shipper or delivering to a consignee or address any transportable thing or vehicles with mechanical defects during the time it takes to make emergency repairs.
